1. WELCOME AND APOLOGIES FOR ABSENCE

4. MINUTES

4.1 Governors received the minutes of the Governing Body meeting held on 15 May 2017 and agreed these to be a true and accurate record of the meeting.

Item 7 of the minutes refers:

Governor Services were to confirm that the Silver Service SLA includes the training package. Confirmation was not received, but the Clerk confirmed that the training package is included in the Silver Package SLA.

Governing Body agreed the Silver Package SLA.

5. CHAIR'S ACTION

There was no Chair's action to report.

6. HEADTEACHER'S REPORT

Ms Augustin presented the Headteacher's Report for the Spring Term., a copy of which was emailed to all governors. The governors duly noted the report. Ms Augustin highlighted:

School Roll

There are currently 462 pupils on roll at Handsworth (including Nursery).

The new Reception intake pupils for 2017 have attended their first familiarisation visits. Four sets of twins joining the cohort this year. Admissions policy is being amended to state that in the case of twins/multiple birth siblings, parents will be consulted regarding class (not teacher) allocation.

Free School Meals (FSM)

The FSM uptake for the Summer term is 5% (23 pupils). 79 pupils in KS2 have school meals. 156 pupils in KS1 (87.15%) have Universal Infant Free School Meals. (UIFSM).

245 pupils are registered for school dinners. There is a reduction in the number of school dinners for the summer term (88.89% Spring) due to pupils wanting to sit outside for packed lunch.

Looked After Children

8 Post LAC children/Adopted from care.

Ethnicity Profile

Approximately 38.75% of pupils are from white British backgrounds (compared to 39% 2016) 60.8% of pupils are from other ethnic groups, compared to 60.6% last year.

English as an Additional Language (EAL)

One pupil who has been elective mute in Nursery has spoken during her visit to Reception class. This pupil had told her mum in her home language that she would start to speak as soon as she moved to 'big school'.

PE and Sports Funding

A number of lunch time clubs run by the sports councillors, year six leaders and a group of year four girls. These include ten pin bowling, jumping and skipping, football tennis and dance. They are mostly aimed at year 2-4 and have been very popular.

London Youth Games - Three teams (Rugby, Hockey and tennis) represented WF at LYG this year. An outstanding achievement. Hockey and tennis finishing 5thout of the 32 London boroughs.

Bronze Ambassadors and two Year 6 Sports councillors helped out at KS1 and were very helpful and responsible.

The school will apply again for the Gold Sports Mark. This would be the third year in a row if achieved.

Next year, two trainee teachers arriving at Handsworth have a background and passion in sport and have been approached to supervise some further opportunities. This will be part of the PE Action Plan next year.

Behaviour and Safety

The Metropolitan Police came to school to deliver workshops to children and parents in Year 6 regarding behaviour, the law and criminal activity/staying safe on social media. The feedback from both children and parents was very positive. The parent sessions were well attended.

Project Encompass: - The school had been involved in a borough wide project with the police and social services. Two members of staff are helping to lead the project for the LA (JA and AS). The school is also involved with providing and delivering the training for school based staff. The project involves schools being notified by 9:00am by the police if a child has been in the home where a domestic violence incident has taken place the previous night. The school can then take appropriate action following knowledge of the incident.

Mindfulness & Pupil Mental Health & Well-being

Play therapist has been working with Year 4 and 5 to promote a mindfulness and support pupils emotional resilience and well-being. This will be rolled out across the school from September.

SEND/ Inclusion

Two pupils awaiting EHCP plans. There are a further two pupils where requests have been submitted to the LA, pending decisions.

Three pupils awaiting assessment for ASD, with a further three awaiting assessment for ASD and or ADHD. Three further pupils are awaiting assessments from CAMHs. All pupils awaiting ASD/ADHD or CAMHs have been fully assessed by the EP.

Attendance & Punctuality

8 penalty notices are due to be issued this term, an increase from 3 last terms. The attendance target set by Governors for 16/17 is 97%. We also monitor the attendance of our vulnerable groups, including PP pupils.

Quality of Teaching

The Performance Management of all teaching staff for the Summer term is complete. The School advisor observed 50% of the lessons to ensure SLT judgements were accurate. 39% of lessons were observed as outstanding, with 94% good. We are delighted that our two student teachers, Mrs Buckley and Miss Moore have successfully completed their teacher training Schools direct year.

Staff Absences

Continuing to closely monitor staff absence, following the school's absence policy.

How effective is Leadership & Management / School capacity for sustained improvement?

- The school has received a positive KS2 moderation report. All judgements by the teaching staff were judged as wholly accurate with no development points.
- Four members of staff passed the moderator training by the STA.
- The SDP and SEF are being reviewed to include the end of year data
- A new behaviour policy is being introduced with effect from 1/9/2017. Staff have had the opportunity to review and input.
- Parents were written to regarding the restructuring of classes. The year group teachers have worked hard to re balance the classes and take into consideration at least one key 'friend' per class. Parents will be informed on Friday 14th, along with the distribution of the end of year reports. Children will meet their new class teachers and classes on Monday 17th. The teachers are planning team building and settling in activities for the beginning of the academic year.

Budget

The school budget is on track. Mrs Carroll presented the budget at the Resource Committee on 04/7/17.

Community Cohesion

- Friends of Handsworth continue to do a great job and hosted an amazing annual school fete.
- Both sports days were very well attended by parents, carers and grandparents.
 The children thoroughly enjoyed.
- 5 students from Highams Park join us on work experience placement this term.
