1. **WELCOME AND APOLOGIES FOR ABSENCE**

1.1 Mr Jarvis, as Acting Chair, welcomed all to the meeting. Apologies received and accepted from Alina Harris, Gabriel Gottlieb, Michael Fear and Donna Carby.

- 1.2 Apologies not accepted: None.
- 1.3 The meeting was quorate.
- 1.4 Notice of Any Other Business: Four items noted.

2. DECLARATIONS OF INTEREST

- 2.1 Pecuniary interest forms have been completed.
- 2.2 There were no declarations of interest in any of the agenda items.

3. GOVERNING BODY

3.1 To appoint one co-opted governor:

Governors discussed the vacancy and agreed that a governor with legal experience would complement the existing skill set. This was evidenced in the completed skills audit. Ms Wilson noted that she had spoken again with Governor Services who confirmed that there are no candidates on their records with legal or communications experience currently available.

- 3.2 Clerk to confirm Governing Body membership:
 - The Clerk confirmed that there were no terms of office ending before the autumn term 2018.
- 3.3 There was no consideration of disqualification for non-attendance.
- 3.4 All DBS checks have been completed.

4. MINUTES

4.1 Governors received the minutes of the Governing Body meeting held on 10th May 2018 and the Extraordinary Governing Body meeting held on 12th July 2018 and agreed these to be a true and accurate record of the meetings.

5. SAFEGUARDING To receive a report on the school's safeguarding arrangements

Ms Augustin reported that Ofsted looked at all Safeguarding arrangements and found them to be fully compliant. Due diligence by Reach2 also reviewed Safeguarding arrangements and found them to be fully compliant.

6. HEAD TEACHER'S REPORT to include a report on the school's Pupil Premium Strategy for the current year (standing item)

Ms Augustin presented the Head Teacher's Report for the Summer Term, a copy of which had previously been emailed to governors. The governors noted the report.

Ms Wilson added that updates in relation to the School Development Plan and School Improvement Priorities are also covered in the report, highlighting:

Boys' Writing

There remain some gaps in Writing attainment between boys and girls, in Years 2 and 5. The Key Stage 2 SATs evidenced that girls at Handsworth attained at a higher level than boys in their writing. Girls' average scaled score is 115.4. Boys' average scaled score is 104.1. However, boys made very good progress in their Writing, exceeding progress measures nationally and broadly in line with the girls at Handsworth. Boys' progress in Writing is 2.4. Girls' progress in Writing is 2.8. National average progress measure is 0.

Ms Winder: Why the difference in attainment and what has caused the improvement in Boys' progress?

Mr Tromans: We have been able to inspire and motivate the children to write creatively and passionately by bringing learning alive inside and outside the classroom. By giving writing a purpose it has motivated individuals to do their best and achieve targets. Fossils were 'found' and the children wrote a letter to the National History Museum, a national competition was entered after writing a mystery story and our own Year 6 Slam Poem competition was introduced and judged by a professional slam poet via video message. Children were also supported through group work where they were able to write for reasons that interest them. Furthermore, teachers are consistently thinking of ways of linking other areas of the curriculum with writing for a purpose. E.g music, art, P.E and P4C.

Ms Augustin: Both girls and boys are above national average in attainment and progress. The difference in the school has been highlighted and actions have been prioritised.

Pupil Premium

Outcomes for Pupil Premium children in Key Stage 2 SATs evidence that in Writing (100%), Maths (90%) and GAPS (80%), PP children have achieved higher attainment than all pupils nationally. In Reading 70% of PP achieved the expected standard (75% national). One child equates to 10% as there are 10 PP children in the year 6 cohort. In R, W and M, Pupil Premium children made more progress that their Non-Pupil Premium peers at Handsworth and more progress than 'all pupils' nationally.

The Governing Body received the Data results and noted that pupils at Handsworth continue to attain at a standard above the national average. Pupils demonstrated progress above national averages in Reading, Writing and Maths. Maths will continue to be a school priority in 2018/19 as progress in this subject was not as significant as in Reading and Writing. Governors discussed the relative merits of setting in Maths, as historically this has been the case in Handsworth. Governors noted the inevitable learning time lost in transition between classrooms. There is also research which raises doubts about the benefits of setting. Governors agreed to trialling Maths in class

groups with appropriate differentiation. This trial will commence in the autumn term, parents will be notified and outcomes will be monitored closely.

Mr Jarvis acknowledged excellent results across all year groups and noted the concern with Maths, which although above national average, are not as good as Reading and Writing and noted the steps being taken to remedy that in the autumn term.
