RE: New statutory curriculum of Relationships and Sex Education 2020 Parent Consultation

The Department for Education (DfE) has announced changes to its Relationships and Sex Education (RSE) curriculum. These changes need to come into effect in all schools by the Summer Term of 2021 at the latest and all schools will be required to comply with the updated statutory requirements by this date.

What is changing?

The DfE are introducing statutory Relationships Education at primary school in order to put in place the building blocks needed for positive and safe relationships of all kinds. This will cover: family and friends; how to treat each other with kindness and recognising the difference between online and offline friendships. This curriculum was last updated 19 years ago so there was a clear need for updates to certain sections.

Health Education is also being made a statutory element of the curriculum at primary level. Health Education aims to give your child the information they need to make good decisions about their own health and wellbeing; to recognise issues in themselves and others and to seek support as early as possible when issues arise.

This means that we will be reviewing our RSE curriculum and policy so we can be sure our provision is appropriate for our pupils based on their:

- Age
- Physical and emotional maturity
- Religious and cultural backgrounds ٠
- Special educational needs and/or disabilities



We plan to teach the Relationships Education and Health Education curriculum within our Personal, Social, Health and Economic (PSHE) lessons, statutory elements from which parents cannot opt out.

Sex Education

We believe it is important for children to be taught about puberty in Year 5 and conception in Year 6 in a way which is appropriate to the age and physical and emotional maturity of our pupils. You have the right to withdraw your child from parts of this learning and you are welcome to view the resources before they are shared with the children.
